Alex had been hanging out in Terry's room with other friends in Dedmond Hall on Friday, December 12. Alex consumed a lot of alcoholic beverages and was really "out of it." Alex vaguely remembers that Terry was kissing her and that she tried to push her away. Then she remembers that Terry sexually assaulted her.
